Sir.

I am to submit herewith a complaint on the mob attack which occurred at about 4.15 pm on 04/05/2023 involving snatching/looting of arms and ammunitions from the Arm Kote of the Battalion Headquarters.

That on 04/05/2023 at around 4.15 pm, a huge mob comprising of only men armed with guns, sticks, swords, etc suddenly barged into the campus of 9th IRB(M), Khuman Lampak with the intention of looting arms and ammunitions from the unit Arm Kote. To prevent the looting, struggle/flight ensued between women personnel/officers and the mob/armed men. Since 9th IRB(M) is a Mahila Battalion comprising mostly of women, the armed mob committed assault on the Mahilas who tried to stop them and a number of them were injured in the process. So, I would like to request you to kindly register a case of assault mostly on women on this matter for further investigation.
