



Subject:- **Report on looting, vandalism and stealing of Shop items.**

Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

1. That, I, Shri Thomte Pauzalian aged about 54 years S/o (L) T Thangzadal, belonging to the Paite tribe/community, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989.** and that, I am a permanent resident of Langol, Laimanai, Paite Colony, Imphal West, Manipur.
2. That, I am the proprietor of M/S P.T. Marketing, Shop No. 3963, ARN: AA140622004865F, GSTIN No. 14BPLPP1225H1Z1, dealing with sales of Home Appliances, Herbal Products etc. Situated at Khuyathong, Pukkhrimapal, P.O./P.S. Lamphel, Imphal West, Manipur.
3. That, due to escalation of ethnic cleansing by the majority meitei/meitei community against the minority tribals of the States, for of our lives and security concern we were compelled to flee/deserted our home and shops, and reached Churachandpur on the 9th of May, 2023.
4. That, during our absence on the 12th of June 2023, at about 9:00 pm a huge contingent of armed radical Meeitei/Meitei suspected to be members of the Arambai Tengol and Meitei Leepun attacked my rental store situated as mentioned hereinabove and in the process, they have looted, vandalized and stolen all the shop items, and that, it may be reported here that the above said criminal activities have caused a grave mental agony and incurred huge loss which may be estimated to be at an amount of Rs 1,54,52,000/- (Rupees One Crore Fifty Four Lakh Fifty Thousand and Three Hundred) only.

In the given circumstances, I humbly pray you to kindly register an FIR/ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions/laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
