Today i.e., 01/10/2023 at about 8.35 pm received an information that on the same day at about 8.32 pm two wheeler Aviator bearing registration No. not known black in colour ridden by unknown rider which was coming from Imphal side towards Thoubal side collided with one Honda Activa bearing registration No. not known maroon in colour coming from Lilong Arapti towards Arapti Lamkhai along NH-102 adjacent to Arapti Lamkhai crossing due to rash and negligent driving on the part of the unknown rider of both two wheeler vehicles. As a result of which, both the riders and the pillion rider of the Honda Activa received injury on their persons and evacuated to hospital for medical treatment and the vehicles were suffered damages.

Hence, a suo-mottu case under FIR No. 74(10)2023 LIL-PS u/s 279/338/427 IPC has been registered for investigation.
