Sir,

I have the honour to state that on 12/10/2023 at about 2.00 pm received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunition and explosive in the Ushoipokpi Makha Sangomsang near watchmen house of Waithou Protected Forest Area on the eastern side of the NH-102 for their atrocity.

On received of the information, special operation group (SOG) Thoubal Districts Police along with COB Lilong 33 Assam Rifle led by Addl. SP(Ops) TBL assisted by OC/CDO-TBL and OC Lilong PS under the overall supervision of SP Thoubal have rushed to the spot immediately and launched a massive search operation at 2.40 pm by using metal detectors. On searching, found the undernoted arms and explosive items i.e. 1) 01(one) no. of SLR bearing Regd. No 15131096 2) 05(five) nos of SLR Magazines and 3)03(three) nos of live 51mm mortar bomb HE.2A having LOT Nos 927A K.F.5 09, 443A K.F.2 06 and 443A K.F.2 06 respectively from the spot and the same have been seized at 3.15 pm by observing formalities. The massive search operation was conducted on the same day from 2.40 pm to 4.00 pm.

It is therefore, handed over the seized incriminating articles to you for further necessary legal action.
