Today i.e. on 25th October 2023 at 11.30 am received an information that on the same day at about 11.20 am one Honda Dio white & blue in colour B/Regd. No. Nil which was coming from Thoubal side towards Lilong side collided with one Tata Hyva B/Regd. No MN01A/4535 which was also coming to the same direction along NH 102 located at Lilong Hangamthabi near Islamic English High school due to rash & negligent driving on the part of both unknown driver & rider. As a result of which Honda Dio rider succumbed at the spot due to the injury. The Honda Dio was also partly damaged.
