Sir,

I am to state that, on 8th May 2023 at about 6:30 PM our locality Canan Veng, under Imphal Police Station, Imphal-East was under not attacked by thousands of unknown miscreants belonging to Meitei community suspected to be a members of Arambai Tengol, Meitei Leepun, Kangleipak Komba Lup (KKL), wall meitei council (WMC), Schedule tribe demand committee (STDc) with criminal intention to cause damage of properties and life. They were armed with deadly weapons including license gun, SCB, knives, Dow rod etc. They looted all the household properties and vandalised my house. The approximate total loss of properties would be 1.25 Crores.

I therefore kindly requested your good office to take necessary legal action to arrest the culprits involved in the incident at the earliest in the interest of justice.
