

Report on Unlawful Assembly Criminal Intimidation, Promoting enmity between different groups on ground of religion and race, uttering words etc with deliberate intent to wound the religious feelings of any person, Attempt to murder, Theft in dwelling house etc, Robbery, Dacoity, and Criminal intimidation and other unlawful activities committed by the unruly goons belonging to Meitei/Meitei Community.



Sir/Madam,

I/We have the honor to state the following few facts for your kind perusal and necessary legal action.

That, we, all the undersigned, belonging to various recognized Schedule Tribe(s) of Manipur, a student's of B.Sc Nursing, presently studying in the College of Nursing, Medical Directorate, Lamphelpat, situated at Lamphelpat, P.O. & P.S. Lamphel, Imphal West, Manipur, on the 4th May, 2023, at various instances has faced criminal intimidation with life attempt by a group of unruly goons coming from RIMS Road towards our hostel by chanting a slogan like "**Kangleipak na yay pha re**" and "**Hao Hatlo**" by carrying a deadly weapons like sharp iron rod, Sword, Dow, Knife, Sticks and Single/Double/Automatic Rifles.

That, we are forced to flee from our hostel on the same day/night on account of the above mentioned compelling situation/scenario. It may be pertinent to mention here that we are left with nothing as I/we had to run for my/our life with a narrow escape. These Meitei/Meitei unruly goons are belief to robbed, looted, destroyed and vandalized valuable movable/immovable property(s) and other valuable documents from my/our our hostel and its premises worth around Rupees 50,000 x 3 = 15,0000 -(Approx.). I/we are presently taking shelter at various places within Churachandpur District, Manipur.

Now, therefore, with outmost respect, I request your good office to take strong actions against the perpetrators by registering an FIR under the relevant provision of law investigate the matter at the earliest and booked the culprit(s) according to the law of the land.
