

Today i.e. 27/09/2023 at 12.40 am, received an information that on the same day at around 12.30 am, a huge unruly mob numbering about 1000 staged a protest along Uripok Kangchup Road by blocking the road, vandalizing, arsoning the tyres on the road and disturbing the law enforcing security personnel of Imphal West who are readily putting effort to disperse the unruly mob. In that the mob attacked the Police personnel by pelting stones, attacking by throwing wooden rods against the Police personnel who were on duty. The unruly mob restrained the Police personnel from discharging duty. As such the Police used minimum lethargic weapon by using the tear gas shells and dispersed the crowd. In that one security personnel identified as C/No. 1901272, Yangabam Aruhzetlee (29) S/o Y. Biren Singh of Wangjing Heitupokpi, Thoubal received injuries in his chin and other body parts hit by stone pelted from the mob.

Hence, a suo-motu case under FIR No. 785(9)2023 IPS u/s 147/148/188/353/326 IPC & Sec 3 of PDPP Act has been registered against the unruly mob for investigation.
