Today i.e. 27/09/2023 at 7.40 pm, received an information that on the same day at around 7.30 pm, the Police Gypsy of SDPO-Porompat, Imphal East was halted by a huge mob at Moirangkhom in the mouth of Thumbuthong. There the unruly mob numbering about 200 individuals overpowered the team of Shri Tejbir Singh, SDPO-Porompat, I/E and capsized the Gypsy, vandalized and finally burnt down the Gypsy.

Hence, a suo-motu case under FIR No. 787(9)2023 IPS u/s 147/148/188/353/436 IPC & Sec 3 of PDPP Act has been registered against the unruly mob for investigation.
