
IMPHAL POLICE STATION



Today i.e. 27/09/2023 at around 11.00 am, a huge crowd mainly students from different directions came and flocked together at Yaiskul Moirangkhom, Imphal. Immediately, a Police team comprising of SP-IW, Addl. SP(Admin)IW & myself (OC/Imphal-PS) along with escort parties rushed to the area where the students were asked to disperse from the place and not to cross beyond the Krishna Premi Oil Pump junction. The mob was huge in numbers nearly about 2000 individuals. They were convinced not to stage the unlawful assembly where the students blocked the National Highway 102 at Yaiskul Moirangkhom. The situation became worse and it was convincingly large in a violent mob where the mob was out of control. So, the RAF personnel & Army personnel also arrived at the spot as requisitioned by SP/IW. At about 12.15 pm, the mob started pelting stones and used catapults against the security forces by using the pieces of iron cuts of 6 mm, 8 mm iron rods from behind the student groups. There were many non-student agitators in the mob. Ultimately, the security forces resorted to the use of non-lethal weapon like Tear Smoke Shell (long & short range) to disperse the mob with the permission concerned Magistrate. In that some agitators sustained injuries on their bodies. And one RAF personnel was also injured in the tussle with the agitators. Moreover, some vehicles of the security forces were also partly damaged in the mob dispersal drive.

Hence, a suo-motu case under FIR No. 788(9)2023 IPS u/s 147/148/188/353/326/427/34 IPC & Sec 3 of PDPP Act has been registered against the members of the unruly mob for investigation.
