

Subject – Report on vandalism & looting of properties

Sir,

I am to bring to your notice that on the 19th of May, 2023 at around 2:00 to 3:00 pm, My residence located at Thangmeiban, Imphal West, P.O. & P.S. *Imphal* was attacked, destroyed, looted and burned by a Group of Meeitei/Meiteis miscreants. They were shouting slogans like- "KANGLEIPAK YAIPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities.

These criminals broke open my gate(s), destroyed and looted every valuable property from my apartment and premises worth Rupees 7,75,000/- (Seven Lakhs Seventy Five Thousand) Only (Approx.) and they burnt down all the remaining things.

Therefore, with utmost Respect I request you to take strong actions against the perpetrators by registering a ZERO FIR under relevant sections of the Indian Penal Code.
