destroyed, looted and burned by a Group of Meeitei/Meiteis.

These criminals broke open my gate(s), destroyed and looted every valuable property from my "Owned/Rental" house, and premises worth Rupees 10 lakhs 50 thousands (Approx) and they burnt down all the remaining things.

Therefore, with utmost respect, I request you to take strong actions against the perpetrators by **registering an FIR** under relevant sections of the Indian Penal Code.
