

**Subject : Report on crimes of looting, vandalism, criminal intimidation, unlawful displacement and discrimination of Scheduled Tribes.**

Dear Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Schedule Tribe belonging to the *Any Kuki Tribe*, a recognized Scheduled Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989.**

Thaqt my daughter @ *Lyzia Moinunnnem* is a student pursuing her **2<sup>nd</sup> Semester (B.Ed)** under Manipur University (M.U), Canchipur bearing **Enrollment No. 2210107506615**, residing at her Aunt's House namely, Chongneikim Singson (9362899173), Thangmeiband, Khomdram Sellungba Leikai, Imphal-West Dist. P.S. - Imphal-795004.

That, on the **3<sup>rd</sup> of May, 2023** at around **5:15 PM**, my daughter escaped from the said campus taking refuge at Central Reserve Police Force (CRPF), Lamphel. And, the above-mentioned resident was looted and vandalized by miscreant's mob belonging to the Meetei community suspected to be members of Arambai Tenggol and Meetei Leepun on the **5<sup>th</sup> of June, 2023** at around **3:30 PM**.

That, it may be mentioned here that her *Academic documents, study materials / books along with her personal belongings* which she deserted are now looted and vandalized which is estimated to be worth about **Rs. 45,000/- (Rupees Forty-Five Thousand)** Only. I would also like to add that, she has been facing difficulties in going to the Valley/Imphal area to continue her studies due to the on-going ethnic crisis in Manipur. Therefore, as a mother its really heartbreaking and disappointing to know that the said University still has regular classes and also conducted examination during the absence of the students belonging to the Kuki/Zo Tribes.

In the given circumstances, I humbly pray you to kindly register a **ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged. And, thus I am filing the report lately today on her behalf as her Father is taking care of her Grandmother who is unwell.
