

With due respect, I, the undersigned would like to lay down few lines before you for your kind consideration and necessary action.

I stayed in rent at Zomi Villa, Imphal in the house of K. Gambhi Singh till 3<sup>rd</sup> May, 2023. I had to leave my rent on 4<sup>th</sup> May, 2023 with all the properties in it due to the conflict between the Meiteis and the Kukis. In spite of the difficulties that I faced I was asked to pay the rent fee by the landlord as my things were still in my rented room and I continued to pay the rent fee for three months after I left. The landlord also assured me that my properties would be safe as I still pay them. However, on 4<sup>th</sup> August, 2023 the landlord called me up and said all my properties had been stolen. The properties include: Gold Ear Ring, Mattress, Blankets, syntax, all kinds of kitchen materials, books, tables, chairs, clothes, Electric motor etc. The monetary value of the lost properties are estimated to be about 5 lakhs.

I, therefore, request you to kindly take the necessary action in this regard in which I shall ever remain thankful to you.
