I, the undersigned have the honour to state that a audio recording is being surfaced on social media that one Thounaojam Brinda (Retd. MPS) mentioned that the ongoing Manipur ethnic clashes is being ignited by the undersigned/ Arambai Tengol/ Meitei Lipun since 3rd May, 2023 and the undersigned have burnt down many Meties houses on advice of Hon'ble Manipur Chief Minister at Churachandpur and the undersigned was arrested for political gain which is totally unproven for political mileage gain of the accused person.

It is pertinent to mention that the accused person have also even threatened to attempt of life of the undersigned such baseless allegation have threatened the life and security of the undersigned and his dependents and such allegation is likely to instigate the undersigned be attacked by the Meties community due to the unsubstantiated allegations of the accused person and have hampered irreparable loss and injury to the Hon'ble Chief Minister of Manipur and the State Government before the eyes of the public of the state and if not immediate action be take a false image be framed against the undersigned.

In light of the above facts and circumstances kindly take appropriate action to give direction to the OC, Imphal Police Station to lodge a FIR and arrest the accused person for ends of justice.
