Today i.e. 07/10/2023 at 09:50 pm, received information that on the same day at around 09:40 pm, some unknown person hurled one Bomb and exploded near the Gate of Hon'ble Minister Shri Yumnam Khemchand Singh at Singjamei Yumnam Leikai. As a result of which two persons namely i) SI Dinesh Chandra Das (57) yrs S/o Late Siddeswar Das of West Bengal, F/30-Bn, CRPF received injuries on his right hand and ii) Yumnam Purilesha (24) yrs D/o Y. Leeder Singh of Singjamei Yumnam Leikai, Lairembi Maning also received injuries on her left toe. Immediately, they were to Hospital for medical treatment and one electric pole was also damaged as hit by the splinters. Whereby, human lives have been endangered by exploding the bomb by the unknown miscreants.

Hence, a suo-mottu case under FIR No. 799(10)2023 IPS u/s 307/338/427/34 IPC, 3 Expl. Subs. Act. has been registered against the unknown miscreants for investigation.
