


Subject: - Report.



Sir,

I have the honour to state that today i.e. 08/10/2023 at about 10:15 am received a reliable information about the presence of some active cadres of KYKL organization an outlawed banned organization in and around Sagolband area. Acting on the information, teams of CDO-IW led by Inspector P. Achouba Meetei OC-CDO-IW and myself under the supervision of Shri M. Amit Singh, MPS Addl.SP(Ops.) IW rushed to the said area and conducted frisking and checking at Sagolband near Jiri Parking. During that, one unknown person was found standing hanging a black coloured side bag in a very suspicious manner at Sagolband near Jiri Parking. Due to his suspicious nature, he was detained for spot verification and checking. On spot body search, the following articles were recovered from his possession:-

- (i) 3 (three) mobile handsets i.e., (a) 1 (one) Cellector C9+ mobile handset along with one Airtel SIM card bearing no. 0523 ID 899116099002325234IU (Ph. No. 7085274899 as disclosed by him), (b) OPPO F19s mobile handset along with one Jio SIM card bearing no. 89918650400117946071 (Ph. No. 9863240537 as disclosed by him) and (c) 1 (one) Samsung Galaxy A70 mobile handset along with one Jio SIM card bearing no. 89918650400017563422 (Ph. No. 6009110711 as disclosed by him).
- (ii) One side bag black in colour containing:-
  - a) 1 (one) 9mm pistol (browning) bearing body no. 16210290 along with 1 (one) magazine loaded with 3 (three) live rounds (suspected to be looted from security forces),
  - b) A sum of Rs. 45,000/- (rupees forty five thousand only) extorted from general public,
  - c) 1 (one) ID card and 1 (one) stamp along with stamp pad,
  - d) 5 (five) small pieces of paper printed as "7085274899 (KANGLEI) MANGAL"

During spot verification, he identified himself as Leimapokpam Rajendro @ Boiler @ Ibungo @ Punshiba Singh (40 yrs.) S/o. L. Nando Singh of Ningombam Awang Leikai. On preliminary verification, he disclosed that he is an active member of KYKL organization and joined the said organization since 2016 and presently working under the command of one s/s Revenue officer Roshan of KYKL organization and one s/s Major Mangal @ Litpa of KYKL organization. He disclosed that under the instruction of his commander's, he had extorted huge amounts of money from general public for party fund. Later, he also disclosed that, he is also a member of Langthabal Ningombam Gram Panchayat (12/8/6). Hence, he was arrested at the spot at 11.00 am and the recovered items were seized at 11.10 am by observing formalities.

The arrested person along with the seized articles are handed over to you for taking further necessary legal action against them.
