Subject:- Report on assault and Grievous Hurt on personal body with intension to kill for being a Tribal (ST) at RIMS Road, Near Babina Diagnostic Centre, Imphal P.O & P.S- Lamphel & District-Imphal West on 04-07-2023 at around 1 to 2 PM.

Sir.

With due respect, I the undersigned would like to make a report to your good office about assault and Grievous Hurt on personal body with intension to killfor being a Tribal (ST) at RIMS Road, Near Babina Diagnostic Centre, Imphal P.O & P.S- Lamphel & District- Imphal West on 04-07-2023 at around 1 to 2 PM by a group of Meeitei/Meitei's suspected to be members of the Arambai Tengol and Meeitei Leepun along with some women folk.

At the very outset, I would like to draw fewline for your information that due to the present situation of ethnic class between Tribal and Valley base Meltei/Meeitei from 3rd May, 2023. That, due to my ailment Liver Dialysis at RIMS for one year, I along with my wife were staying at relative resident at Uripok, Near Sangai Health Care, Pachas Patil P.O & P.S- Lamphel & District- Imphal West and on the said day of 4th May, 2023 while returning from RIMS after getting treatment of Liver Dialysis, I along with my wife were stop on our way and taken to RIMS Road, Near Babina Diagnostic Centre. On reaching the place the said group of Meeitei/Meitei's suspected to be members of the Arambai Tengol and Meeitei Leepun started to beat me up on my body, I pleaded to them to spare my life because I am suffering from Liver problem and presently coming back from Rims after taking Liver Dialysis at RIMS but they did not pay any head to my request rather shouted to me that we will kill you because you are Tribal (ST) and some of the women who were present among them started to lay hand upon my wife with a log. Thereafter, I was hit on my head and other parts of my body of which they tried to kill me and left me to my faith thinking that I am death. But Luckily, some of the police personal who are coming for duty came on the spot and rescue my wife and me. I was urgently admitted at Raj Medicity, Near A.O.C, Imphal West-795001 thereafter, I got treatment at the said Medicity and was shifted to Assam Rifle Camp at Mantripukhri, Imphal on 5th May, 2023. After, staying for 3 days, we were transported to Churachandpur and presently, I still taking treatment for my ailment which was cause by the said act of the said members.

It is requested to your good office to make entry of my report a Zero F.I.R and take action against all the above mention members who tried to kill me with my wife for being a tribal (ST) as per Law and also issue me the copy of the said report for my reference in future. I could not make the said report on time due to avoidable circumstance of mine in taking medical treatment due to my ailment. Looking forward for your help. Thanking You
