

Subject: - Report.



Sir,

I have the honour to state that today i.e. 13/10/2023 at about 11:20 am received a reliable information from our own source about the presence of some active cadres of KCP organization in and around Thangmeiband area with a view to commit prejudicial activities like extortion of money from the general public etc. Acting on the information, teams of CDO-IW led by Inspector P. Achouba Meetei OC-CDO-IW and myself under the command of Shri M. Amit Singh, MPS Addl.SP(Ops.) IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted frisking and checking in front of Hot Bite Cafe near THAU Ground, Thangmeiband. During that, one Maruti Baleno black in colour without registration number coming from Lilasing Khongnangkhang side towards our frisking zone was stopped for checking at the spot. When our team rushed to the said Maruti Baleno car for spot checking, the occupant of the vehicle tried to flee away and subsequently, I along with my personnel successfully detained him. On spot checking of the detainee, 1 (one) 9 mm pistol bearing body no. 18305913 along with one magazine loaded with 4 (four) rounds of 9 mm ammunition which was kept concealed on the right side of his waist was recovered. On further body search, (i) 1 (one) Redmi Note 10 mobile handset along with one Airtel SIM card bearing no. 8991160990017857966U (Ph. No. 7085925272 as disclosed by him) and (ii) 1 (one) brown wallet containing one Aadhaar card were recovered. On spot verification, he identified himself as Yendrembam Goutam Meitei (25 yrs.) S/o. Y. Ahongjao Meitei of Sekta Mayai Leikai, Sekta Museum Road, Sekta, Imphal East District.

At the same time, the driver of the vehicle was also force to come out of the vehicle and detained for spot verification and checking by our personnel. On checking his camouflaged side bag, 1 (one) pistol marked as .32 7.65 pistol MADE IN JAPAN along with one magazine loaded with 3 (three) rounds was recovered. On further spot body search, (i) 1 (one) iPhone XR mobile handset along with one Airtel SIM card bearing no. 8991160990023428634U (Ph. No. 8131062704 as disclosed by him) and (ii) 1(one) wallet red in colour containing a sum of Rs. 200/- (rupees two hundred only) and 1 (one) Pan card were recovered. The vehicle was also thoroughly checked at the spot. On spot verification, he identified himself as Ningthoujam Chalamba Singh (27 yrs.) S/o. (L) Ningthoujam Subol Singh of Khurai Kongpal Sajor Leikai, Imphal East District.

During preliminary verification, Yendrembam Goutam Meitei disclosed that he is an active member of KCP (City Meitei) organization and started working for the said organization since June, 2023 through one Ngangom Nanao an active cadre of KCP (City Meitei) organization from Sekta Awang Leikai and is presently working under the command of one s/s Chairman Mr. Brojen @ City Meitei of KCP (City Meitei) organization.





During verification of Ningthoujam Chalamba Singh, he disclosed that he is an active member of KCP (City Meitei) organization and joined the said organization in the month of July, 2023 through Yendrembam Goutam Meitei an active member of KCP (City Meitei) organization and is also presently working under the command of one s/s Chairman Mr. Brojen @ City Meitei of KCP (City Meitei) organization. He further disclosed that today morning his commander, Mr. Brojen @ City Meitei of KCP (City Meitei) organization handed him over the above mentioned Maruti Baleno car along with the arms and ammunitions at Khurai Lamlong Bazar for use in their party activities and then he went to pick up Yendrembam Goutam Meitei from his residence for performing party activities assigned by their commander.

Both of them disclosed that, under the instruction of their commander, they had made monetary demands to private hospitals, businessmen and general public etc. in and around Imphal area.

Therefore, i) Yendrembam Goutam Meitei was arrested at the spot at 12:30 pm and the above mentioned recovered articles from his possession were seized at 12:45 pm by observing formalities and ii) Ningthoujam Chalamba Singh was arrested at the spot at 12:50 pm and the above mentioned recovered articles from his possession along with the above mentioned vehicle were seized at 01:10 pm by observing formalities.

Hence, the arrested persons along with the seized articles are handed over to you for taking further necessary legal action against them.
