Sub: Complain report.

Sir,

I have the honour to report you that, on 14/10/2023 at about 10:40 pm, some unknown persons numbering about 20 who came on to 2 (two) two wheelers and 4(four) four wheelers came at the house of Khaidem Seitajit @ Bobo (38) S/O (L) Kh. Momon Singh of Sega Road Konjeng Hajari Leikai near Kwairakpam Leikai Community Hall and attempt to kidnap Seitajit. However, the local people intervened to do so. The unknown culprits started firing towards the public and five persons:-

1. Rk. (O) Medhabati Devi (50) W/O Rk. Manao of Segaroad Konjenghajari Leikai,
2. Nongmaithem Abeison (15) S/O (L) N. Priyobrata of Segaroad Konjenghajari Leikai,
3. Salam Boicha (30) S/O S. Tiken of Sayang Kurao Makhong,
4. Nongmaithem Priyananda @ Tondon (43) S/O (L) N. Mani of Segaroad Konjenghajari Leikai and
5. Phijam Trilokchand (34) P. Tomei of Segaroad Khwairakpam Leikai

received bullet injuries. The culprits attempted to kill the innocent public randomly. The public dispersed due to the firing and taking the chance, the unknown culprits fled away from the spot. The injured persons were evacuated to RIMS and RAJ Medicity hospital for further treatment.

You are therefore, requested to take up necessary legal action against the involved culprit(s) at an early.
