Today i.e. 15/10/2023 at 05.30 pm, received an information that on the same day at about 05.20 pm, one Pleasure bearing Regn. No. MN01Y-3908 (red in colour) which was proceeding towards Tiddim Road, suddenly dashed by one Royal Enfield bearing Regn. No. MN06SC-0434 (black in colour) at Hodam Leirak Maning crossing near Sangai Express Newspaper immediately, again one Royal Enfield (Grey in colour) bearing Regn. MN04G-1938 hit against Royal Enfield bearing Regn. No. MN06SC-0434 at the same spot. As a result of which the riders and pillion rider of the Pleasure and the Royal Enfields received serious injuries on their persons and they were immediately evacuated to Hospital for medical treatments. The said pleasure and the Royal Enfield were badly damaged. Later on the rider of the Royal Enfield (Grey in colour) bearing Regn. MN04G-1938 who was identified as Gurumayum Ashish Sharma aged about 19 yrs S/o G. Rakesh Sharma has succumbed to his injuries. Hence, a suo-mottu case under FIR No. 816(10)2023 IPS u/s 279/338/427/304-A IPC has been registered for investigation.
