With due regards, I have the honour to report that on 20/10/2023 at around 10:30 pm to 11:00 pm, my niece Ahanthem Ritesh Kumar (22) S/o (L) Ah. Onlikumar of Uripok Sorbon Thingel Leikai, Imphal West was shot on the head by Takhellambam Deepu Singh (25) S/o (L) Th. Bijoy Singh of Uripok Polem Leikai, Lane No.2, Imphal West at the residence of Thokchom Yaima Singh (54) S/o (L) of Uripok Khoisnam Leikai, Imphal West for unknown reason. He was called by one Thokchom Yaikhomba (20) S/o Th. Yaima Singh to come to his house to help him in some works. Then at around 11:25 pm, the mother of Th. Yaikhomba called on mobile phone to Ritesh's brother Ahenthem Malemnganba to come over to their house but she didn't give any reason. So, Ritesh's brother went to their house only to find Ritesh lying on the floor bleeding. Soon he was taken to RIMS hospital for treatment and then referred to Raj Medicity for further treatment. He is now in critical condition at ICU.

It is therefore, requested kindly to take necessary legal action against those persons involved in the crime.
