

Subject:- Report

Sir,

I have the honour to report that today i.e 21/10/2023 at 3:30 p.m a team of Traffic Control Police Wing including myself ASI Y. Priyobartan Singh of TCPW was on duty at Singh & Co Moirangkhom crossing, Imphal West for conducting Traffic regulation and conducting drive against traffic violators. While performing duty one Eco van bearing Regd.No MN04P-2319 Silver in colour with Tinted Glass driven by one unknown driver was found coming from Babupara towards Moirangkhom, he was signalled to stop his vehicle but he tried to escape, however our team managed to stop the vehicle. Due to his suspicion nature, he was detained at the spot for verification. On verification he Identified himself as Sorokhaibam Rosses @ Keileipuba (38) s/o S. Chacha of Leingalmtabi Chairel Makha Leikai Moirang PS Kumbi Bishnupur District an active member s/s Lt. of Banned UNLF Organisation having Army No. 1506. On examination he disclosed that he joined UNLF in the year 2001 through one cadre of UNLF name s/s Pvt Kangleingakpa @ Surjit of Thongju and presently working under the command of s/s Lt. Col. Naba of UNLF. Hence, he was arrested at the spot at 3:40 p.m. On body searched (1) One Aadhar Card Nos. 824667802787, (2) One Driving Licence MN06 20220009173. (3) One Voter Card MTN0293050 (4) One Smart Phone Vivo T2x 5G (7005393779) Jio, IMEI1. 866164061362916, IMEI2. 866164061362908 ; One Smart Phone OPPO A 57 (8787494055) of Jio, IMEI1. 863581065027679, IMEI2. 863581065027661; One Phone Celcor (8729987718) of Airtel, IMEI1. 352476511067585, IMEI2. 352476511067593, & (5) Cash Rs.1,75,300/- (One Lakh seventy-five thousands three hundreds Only ( 500 x 347, 100 x 17, 50 x 1, 20 x 2, 10 x 1) notes piece were detected.

On further checking of the vehicle One Eco van bearing Regd. No MN04P2319 Silver in colour (1) 68 (sixty eight) nos. of live round Lathods Ammunition 40 mm wrapped with green plastic sack, (2) 573 (five hundreds seventy-three) nos. of 7.62 live round Ammunition (suspected to be AK) wrapped with green plastic bag containing inside one bag blue in colour, (3) 294 (two hundreds ninety-four) nos. of 5.56 live round Ammunition inside a plastic bottle, (4) 379 (three hundreds seventy-nine) nos. of 7.62 (suspected to be LMG) live round Ammunition inside a plastic bottle were detected.

Hence the above mentioned items were seized at 4:10 p.m from his procession by observing formality.

The arrested person along with seized articles are handed over to you for taking necessary legal action against him according to law.
