Sir,

I have the honour to report that today i.e. 29/10/2023 at about 06.15 pm, my Maruti Alto (Silver in colour) bearing Regn. No. MN01K 3160 having Engine No. F8DN3048155 and Chassis No. MA3EYD81S00285499, registered in the name of Lourembam Surjit Singh S/o L.
