Sir,

I would like to bring to your kind notice that on 28/10/2023, an anonymous tip (video) was received from reliable input/source wherein one unknown victim girl was physically molested by a group of persons. Hence, an enquiry vide GD No. 3/CCPS/2023 dated 28/10/2023 has been initiated.

During the enquiry, on minute examination of the aforementioned video, it is learnt that the victim girl was suspected to be induced with alcohol or any other intoxicating substance making her unconscious. Taking the advantages of the circumstances, the group of persons physically molested the victim girl inside a moving vehicle and recorded the video by one of the culprits without the knowledge or consent of the victim girl.

On further enquiry, through technical and human intelligence, particulars of one of culprits involved in the heinous act namely Boris Maibam (20) S/o. M. Gandhi Singh resident of Kakwa Nameirakpam Leikai, Imphal West could be unearthed and was able to detain him. During preliminary examination, Boris Maibam admitted that he was involved in the act and further disclosed four other associates who were also involved in the crime namely :

- 1). John Maibam
S/o. M. Dayamo Singh
resident of Kakwa Nameirakpam Leikai, Imphal West,
- 2). Melgipson Naorem
S/o. N. Bode Singh
resident of Kakwa Naorem Leikai, Imphal West,
- 3). Purna Okram
S/o. OkramBadal
resident of Chajing Mairenkhong, Imphal West.
- 4). Kshetrimayum Manson
S/o. Ksh. Manglemtomba
resident of Singjamei Mayengbam Leikai, Imphal West.

He further disclosed that the said incident occurred on the last day of Holi festival 2023 i.e. 11/3/2023 at about 2:00 PM wherein they picked up the victim girl from Keishampat near Likla Bakery store. In the follow up action, the other four associates could also be detained.

It is ascertained that the acts of the culprits including the detained person amounts to the molestation/sexual abuse of the victim girl and also the same was recorded by one of the culprits and made it viral. Therefore, all the relevant documents and detained persons are submitted and handed over for taking up further necessary legal action please.
