Today, i.e., 01.11.2023 at about 6 p.m., a large number of Arambai Tenggol, led by one Korou Nganba Khuman armed with sophisticated weapons, sticks and other deadly weapons, wearing camouflaged Manipur Police uniforms including MR/ IRB's and black colour T-shirt coming in many light vehicles rushed in from the north western gate and attacked the 1st Manipur Rifles armed Bn. with intention to kill the security personnel and loot the arms and ammunitions from the Battalion, after the call given in Facebook by their leader Korou Nganba Khuman as "Echil enao Athouba sing lakpiro ngasidi tang taba ama khanghalasi" translated literally as "Please come all brave brothers let us chalk out a final conclusion". They overpowered the sentries on duty and entered the 1st MR compound in large number and started looking for arms and ammunitions. The security personnel of 1st MR and others deployed inside resisted the attack and gunfight ensued between them inside the 1st MR complex. After a while a strong re-enforcement of security forces comprising civil police, Assam Rifles and CRPF arrived and pursued the armed Arambai Tenggol members, they escaped in different direction by taking advantage of the presence of civilian family members of 1st MR. After the operation was over, it was found that the following weapons and ammunitions have been snatched from security personnel during the fight inside the congested 1st MR complex.

One AK assault Rifles bearing No. KW5847 along with 3 magazines and 1. 87 nos of round issued to Rifleman No.0197023 S. Ratankumar Singh.

2(two) gas gun from 1st MR security personnel. 2.

One KT43 (AK rifle) bearing No. 7586 along with 3(three) Magazine 3. and 90 nos. of rounds issued to Const. No. 1801253 Tonso Yanzing. 4.

One KP43 (AK rifle) bearing No. 6795 along with 2(two) Magazines and 60 nos. of rounds issued to Const. No. 1801321 Ssaac Gangmei.

5. One KP43 (AK rifle) bearing No. 6915 along with 3 (three) Magazines and 90 nos. of rounds issued to Const. No. 0901204 Kh. Suranjoy.

6. 2(two) nos. of AK Rifles Magazines and 60 nos. of rounds which is issued to HC. N. Gunindro and Const. No. 093101 N. Herojit. 7.

2 nos. of tear gas guns i.e, 1. 2K16 bearing No. 23158 and 2K15 bearing No. 20964

8. BP cap 6 (six) nos. and BP plate set of 4 nos. 9.

10(ten) numbers of fiber shield. 11(eleven) nos of fiber sticks. 10.

11. 5 (five) nos of Patkas.

12. From armed security of Manipur Central Jail located at Old Lambulane viz., (i) AKM Ghatak bearing Regd. No.203900298 along with 2(Two) Magazine and 60 nos of round

(ii) (2) AKM bearing Regd. No. BA44 -7094 along with 3(three) Magazine and 90 nos. of round

(iii) INSAS Rifles bearing Regd. No. 16841366 along with 3(three) Magazine and 60 nos. of rounds. (iv)

2(two) Magazine of SLR along with 40 nos. of round.

Further, they also destroyed IGP prisons office, Superintendent of Jail office, JCO room as well as the following items took away (1) 01 Bolero for IGP prisons and one hard top Gypsy (2) 02 Gypsy's along with one walkie talkie set attached to the vehicle of Superintend Manipur Central Jail Imphal (3) 01 Gypsy assigned to QRT (4) 01 Hard top Gypsy assigned to senior FO (5) 01 Gypsy assigned to escort of SP Sajiwa. They also enter and ransacked the computer room of Manipur Police control Room and NAB office. They also fired at the office of CID (SB). They also took away another 01 Gypsy bearing No. MN01W0311 which was parked under locked and key at the main gate of Sanamahi Temple, 1st MR which was allocated to W. Ishwarchandra Singh, DY.CO-5th IRB. 3(three) personnel of Alpha/152-CRPF were also sustained injured during the attack.

Hence, a suo-motto case under FIR No. 831(11)2023 IPS u/s 147/148/149/186/188/379A/392/120-B IPC, Section 16/18 UA(P) Act & Section 25 (1-B) Arms Act, 25 (1-AB) Arms Act. has been registered against the accused and others for investigation.
