Sir,

I have the honour to report that today i.e. 01/11/2023 at 05:45 pm a huge mob comprising of only men with Guns, Sticks, Swords etc, suddenly entered into the campus of Manipur Central Jail located at Old Lambulane with the intention of looting arms and ammunitions. Later, on the following arms and ammunitions i.e. 1) AKM Ghatak bearing Regd. No. 203900298 along with 2 (two) Magazine and 60 nos of round, 2) AKM bearing Regd. No. BA44-7094 along with 3 (three) Magazine and 90 nos of round, 3) INSAS Rifles bearing Regd. No. 16841366 along with 3 (three) Magazine and 60 nos of round, 4) 2(two) Magazine of SLR along with 40 nos of round, were snatched/looted by the said unruly mob after overpowered from the campus of Manipur Central Jail, Imphal.

It is therefore, requested kindly to take up necessary legal action against the unknown mob attackers at the earliest.
