Subject: - Complaint report.

Today i.e. on 01/11/2023 at about 6.00 p.m. some miscreants reportedly members of Arambai Tengol numbering about 700 approx, equipped with sophisticated arms stormed the IMR campus through North Gate, 1MR in several SUVs with mounted Arms and on foot with common intention to snatch arms and ammunitions from the armouries of the Bn.

Accordingly emergency alarm/siren was switched on and alerted all the personnel at the battalion including the administrative staffs and all the personnel came into stand-to position. Thereafter, the personnel deployed & the sentry parties of IMR along with CRPF personnel who were deployed at the armory of 1MR fired tear smoke/stun grenades upon the miscreants to disperse them but the miscreants fired live rounds from their fire arms attacking the personnel at the arm Kote. Further, the deployed security forces fired blank live rounds along with tear smokes & stun grenades to disperse the miscreants. At around 7.45 p.m, the security forces effectively managed to disperse the miscreants from the IMR campus and control the situation.

Furthermore, it is to highlight that the following arms and ammunitions were snatched away from the personnel who were performing duty in and around the battalion.

- The armed miscreants break in the office of the Commandant of 1st Bn. Manipur Rifles by breaking the door. They also snatched away one Gas Gun bearing registration No.187102607 Butt No.13 issued to Hav No.0197025 S, Ratankumar Singh from the office. They also pointed their sophisticated arms towards the office runner of the Commandant threatening him.
- One Rifleman No.0197023 Moirangthem Sanjeevan Singh who was deployed near Adm ii. Barrack, fired 3(three) rounds from his service weapon, on seeing the approaching armed miscreants toward the Arm Kote, however he was overpowered by the armed miscreants and snatched away his service weapon i.c. I (one) AK 47 Rifles bearing Registration No. KW5847 along with 3 magazines and 87 live rounds.
- The armed miscreants after being repelled from the Battalion Campus snatched away 1 (one) Gas Gun bearing registration No. 187102604 from the duty personnel deployed at iii. Nityaipat Chuthek issued to Hav No.9867 Th. Loken Singh of 5IRB (concentrated and utilized at 1MR). Further, they also snatched away 5 (five) numbers of fiber shield, 5 (five) numbers of Fiber stick and 5 (five) numbers of Patkas from the duty personnel.
- The armed miscreants also snatched away 5 (five) numbers of fiber shield and 6 (six) numbers of Fiber stick from the duty personnel of North Gate. iv.

Moreover, the 1st Bn. Manipur Rifles Unit Hospital was vandalized by the armed miscreants. It is therefore, submitted for your kind information and to take up further necessary legal actions.
