



Sub:- Report.

Sir,

Most humbly and respectfully I beg the honour to state that today i.e. 01/10/2023 while we were performing D.G. Pool duty, Quartar Guard Duty and main gate duty of IMR. During that time at @ 5:55 p.m, suddenly, a large mob tried to entered and storm the main gate of IMR, most probably the crowd was suspected to be of Arambai Tengol and they attacked our personnel by wearing B.P jackets and arms, with the intention of snatching/looting arms and ammunitions from the IMR, D.G. pool armoury and from the personnel of Alpha/152-CRPF. Small scuffle was broke out between CRPF/152 personnel with crowd of suspected to be Arambai Tengol. They opened fired indiscriminately towards our personnel which were resisted by troops of 152. In which 26(Twenty six) round of ammunitions was fired from our side. Details of the ammunitions which were fired by our personnel are given bellows:-

- 1). AKM-7.62X 39 mm =10 rounds
- 2). INSAS ammunitions= 16 rounds.
- 3). Shell round ( Long range)=1 rounds
- 4). Shell round (Short range)= 2 rounds
- 5). Stunt shell =2 rounds.

4 (Four) nos. of polycarbonate sheet along with 2(Two) Helmet snatched from the guard. During the above said attack on the camp, 3 (Three) personnel got injured and they were evacuated to hospital for treatment. However, 1 personnel was admitted at JNIMs hospital further treatment and other 2 (Two) personnel were discharge after proper stitching.

So, I therefore requested to kindly take necessary legal actions against the accused persons as per law of the land.
