



Sir,

I, Haominlen Haokip of Kangpokpi, Phalcham veng, Ward No. 1 would like to report that I was running a canteen at Dewlahland, 5<sup>th</sup> Avenue, Imphal. On 4<sup>th</sup> May, 2023, while I was in my canteen serving customers, I was attacked by Meitei Miscreants led by Arambai Tenggol and my properties were vandalized and destroyed. I with my family narrowly escaped with our lives. List of my properties vandalized are listed below.

Therefore, I request for immediate action to this effect.
