Subject:-Report of loss of 1(one) office vehicle from the office complex of SP/CID(SB) Office, Jail Road, Imphal.

I have the honour to state that on 01/11/2023 at around 6:00 pm about 1000 unknown armed miscreants stormed 1-MR campus, ADGP(Int)'s office, NAB, CPCR,CID(SB), Central Jail, Imphal and 1-MR Hospital.

The security on duty at 1-MR resorted to firing tear gas shells & live rounds to repel the miscreants. Further, several rounds (blank) were also fired by the miscreants. For protection of office equipments & files and for personnel safety of staff, the main collapsible Gate of CID(SB) office was locked from inside and the staff positioned themselves in safety locations inside the office building.

After sometime the miscreants entered our office complex and around 50 armed miscreants forced the staff of our office to open the collapsible Gate and searched all the rooms one after another for arms & ammunitions. As they found no arm/ ammunition, they left our office.

When the armed miscreants left our office complex after about 1 ½ hour, checking of all the rooms and our office campus was done to take stock of any damage or loss. During this exercise 3 helmets of the staff and one office Maruti Gypsy bearing Registration No. MN1K-4022 (Chassis No. 221325 & Engine No. 158619) white in colour of the office of CID(SB) which was parked inside the office complex of CID(SB) office were found missing.

It, is therefore, requested to look into the matter and take up appropriate legal action to recover the lost items at the earliest.
