I have the honour to report on the snatch of one AK 47 Rifle Butt No. 126 AK, Chassis No. BA-44- 6033 with a magazine of 30 ammunition from Rfm/No. 08200604, H. Stelin of 8th MR Escort to ADGP (Int), Manipur by unknown miscreants. The mob of unknown miscreants stormed 1st MR Bn. and other units with the intention of snatching weapons relating to the present violence in the state of Manipur on 01st November, 2023 at around 06:16 PM. The ADGP (Int), Manipur Escort personnel along with vehicle were parking infront of ADGP (Int) office opposite to Imphal Central Jail, Manipur. Suddenly, the mob showed us and came forward to snatch our issued service weapons. Unfortunately, one AK 47 Rifle was snatched by them and they ran away.
