



Today i.e. 04/11/2023 at 8.30 pm, received an information through Control Room, SP/IW that on the same day at around 8.20 pm, one Bolero Pick up, White in colour, bearing Regn. No. MH47TC098/709 which was coming from Moirangkhom towards Singjamei side along NH-102 dashed against one scooter Jupiter ZX, Blue in colour without Registration Number at Yumnam Leikai Lairembi Mamang due to rash and negligent driving on the part of the Bolero driver in which the rider of the scooter and its pillion rider sustained injuries on their persons and the scooter was also badly damaged. Immediately, they were evacuated to Raj Medicity Hospital for medical treatment. However, the rider of the scooter was declared brought death by the Doctor attended.

Hence, a suo-motu case under FIR No. 842(11)2023 IPS u/s 279/427/304-A IPC has been registered against the driver of Bolero Pick up, White in colour, bearing Regn. No. MH47TC098/709 for investigation.
