

Sir,

I am a law-abiding citizen of India and the present complaint is being filed against the accused persons for taking up necessary legal action and punish them in accordance with law for their unlawful activities. And, I am well aware of the situation happening in the State of Manipur since I am presently residing in the State of Manipur.

A notification under the heading EMERGENCY & RELIEF FUND was issued vide No. KWA/GHY/2023-24/18 dated 5th November 2023 in tribal dialects using roman script, thereby attaching Bank account details and phone numbers, calling to all Kukis around the world for deducting/ contributing 5% of their salary to Kuki Inpi Manipur. These monies are being collected to fund terror in order to wage war against the Government of Manipur.

Another document of such nature was also issued by Kuki Inpi Karnataka (KIK) under the headline Kuki Inpi Karanataka Thuphon (Nisim: Phallha 3, 2023) KIK – Manipur Relief Fund. This is also in tribal dialects using roman scripts. In this Notification also Bank Details along with GPay number is also given for contribution of funds.

The above notifications were uploaded in their respective FaceBook Account and also available in social media outlets.

Copy of Notifications dated 3.11.2023 and 5.11.2023 made by the accused persons is enclosed as K/1 & K/2 respectively.

The accused person and the accomplice have made the above-mentioned notification for raising funds for waging war against the Government of Manipur as such, the same needs to be dealt seriously. The details of the Bank Account, phone numbers mentioned therein needs to be monitored and investigated proper along with other accounts related to the above-mentioned accused persons.

It is worth to mention herein that, the present situation in the State of Manipur which emerged after the unfortunate incident of 3rd May, 2023 started from the Churachandpur thereby spreading to the other parts of the State is returning to normalcy. But in the past few days many new violence incidents has started reported

especially in the Kuki dominated adjoining areas, such as foothills etc. The incidents of firing bullets, threatening to stop cultivation, burning of reaped crops placed for drying before threshing etc. all such illegal activities has started afresh and the above accused persons are raising terror funds from all over the world to provide funding to those terrorists.

In view of the action of the accused persons, these illegal activities including these terror funding to wage war against the State strongly suggested that the accused having nexus with the narco terrorists/ drugs mafia operating in the State of Manipur and as such, the concerned authority may kindly look/ investigate the connection between the accused persons and the drug mafias/ narco terrorist by initiating proper investigation against the accused persons thereby monitoring/ freezing the above mentioned Bank Accounts.

In the facts and circumstances strict legal action may be taken up against the above-named accused persons and his associates by registering a case so as to punish him in accordance with law.


