

Sir,

Please find enclosed herewith 2(two) letters (a) without reference no. and date, addressed to the PCCF and HoFF, Manipur (**ANNXURE-I**) and (b) with reference number MN/10/23 dated 27.10.2023 addressed to the Additional Chief Secretary, Forest Department, Manipur (**ANNXURE-II**) which were purportedly sent from the MoS, MoEF and CC, Government of India through email with copies endorsed to the Hon'ble Governor, Manipur, Hon'ble Chief Minister, Manipur and the Chief Secretary, Government of Manipur.

2. Both the letters mention about one **Mr Pratik Sarkar** from the Ministry of Environment, Forest and Climate Change, Government of India who had already reached Imphal for certain inspections of funds understandably of schemes implemented by Forest Department, Government of Manipur.

3. **Mr. Pratik Sarkar** visited the Forest Head Quarters and also Secretariat: Forest and Environment Department asking to appoint a Nodal Officer from Forest Department to discuss the issues as mentioned in the aforementioned letter.

4. Some officials in Forest Department, both at the Forest Head Quarters, Sanjenthong and at the Secretariat started doubting the person because of his assertive, demanding, aggressive and mischievous behavior.

5. The undersigned, on being asked to do so, officially contacted the Additional Private Secretary (APS) of the Hon'ble MoS, MoEF and CC, Gol Shri Rahul Kumar, IRS on telephone and email on 03.11.2023. Copies of both the letters mentioned above were shared with the APS for verification. **The APS to the Hon'ble MoS, MoEF & CC, Gol replied on email on the same day and informed that these letters were not sent from their end as per records maintained in their office and confirmed the 2 (two) letters as FAKE.** He also added that appropriate legal action be initiated immediately under intimation to the Office of MoS, MoEF and CC, Gol (a copy of the email reply enclosed as **ANNXURE-III**)

It is, therefore, requested to register a case/file an FIR against Mr Pratik Sarkar (ADHAAR No. 4660 9673 0330) for fraudulently preparing letters and communicating with Manipur State Government Offices by using the name and signature of the Hon'ble MoS, MoEF and CC, Government of India and misleading officials with *mala fide* intentions. It shall be advantageous if the intentions of the accused, the other persons involved, local connections etc., among others, are ascertained during the investigation of the case.
