

Today i.e. 13/11/2023 at 11.00 pm, received an information that on the day at about 10.16 pm some unknown miscreants who came by a four wheeler car (red in colour) have fired some rounds numbering about 8/9 at the residence of Shri Kongkham Bikram, aged about 45 years, S/o Kongkham Mangol Singh of Nagamapal Soram Leirak, State Secretary, BJP Manipur with an intention to cause annoyance by causing death or casualty in the said house. As a result of which, one 4 (Four) wheeler car i.e. Alcazar Hyundai Car partly damaged. But, no any casualty of any person was reported.

Hence, a suo-motu case under FIR No. 854(11)2023 IPS u/s 307/506/427/120-B IPC, & 25(1-B) A. Act has been registered against the unknown miscreants for thorough investigation.
