Dear Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the Any Kuki Tribe, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, due to the prevailing ethnic crisis in and around Imphal, I along with my family left our residential-quarter located at Qtr. No. 10. Central Jail Imphal, Old Lambulane, P.O. & .P.S.- Imphal, District- Imphal East on the 4th of May, 2023 at around 6:30 AM. And it has come to our knowledge that our deserted residence was attacked and looted by a Group of radical Meitei/ Meiteis suspected to be members of Arambai Tengol, Meetei Leepun and other Meitei/ Meiteis in and around the area on the 28th of June, 2023 at around 06:15 PM.

That, the looted properties are worth about Rs.25,50,000 /- (Rupees Twenty-Five Lakhs Fifty Thousand) only.

That, due to the reason of transferring from one place to another, I am filing this report lately after reaching Churachandpur dist. And I, therefore, request you to kindly register my case as ZERO FIR and take stern action against the perpetrators under the relevant provisions of the law of our country.
