



Subject – Report on crimes of **vandalism & looting of properties** and **discrimination of Scheduled Tribes.**

Dear Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the Any Kuki Tribe, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989.**

That, due to the prevailing ethnic crisis in and around Imphal, I along with my family left our residential-quarter located at Qtr. No. 10, Central Jail Imphal, Old Lambulane, P.O. & P.S.- Imphal, District- Imphal East on the 4th of May, 2023 at around 6:30 AM. And it has come to our knowledge that our deserted residence was attacked and looted by a Group of radical Meitei/ Meiteis suspected to be members of Arambai Tengol, Meitei Leepun and other Meitei/ Meiteis in and around the area on the 28th of June, 2023 at around 06:15 PM.

That, the looted properties are worth about **Rs.25,50,000 /- (Rupees Twenty-Five Lakhs Fifty Thousand)** only.

That, due to the reason of transferring from one place to another, I am filing this report lately after reaching Churachandpur dist. And I, therefore, request you to kindly register my case as **ZERO FIR** and take stern action against the perpetrators under the relevant provisions of the law of our country.
