



Subject: Report on *Vandalism and Looting* of properties and *Discrimination of Schedule Tribes*.

Respected Sir/Madam,

With reference to the above cited subject, I have the honour to report to your good office as follows:

That, I, Neikim Haokip aged about 33 years W/o Michael Simte belonging to the Simte tribe/community, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**.

That, I and my family are staying in a Government Quarter at 1st MR, Quarter No. B- 2, Old Lambulane Road, Imphal West, Manipur - 795001.

That, on the 25th of June, 2023 at around 7:30 PM, a huge contingent of armed radical Meeitei/Meitei suspected to be members of the Arambai Tenggol and Meitei/ Meitei Leepun attacked our locality and in the process vandalised and looted down our house along with all the properties including one four wheeler Alto 800- bearing Regd. No MN06L7376, white in colour.

That, it may be reported here that above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated (approx.) to be **Rs 20,00,000 /-(Rupees Twenty Lakh)** only.

Fortunately, me and my family managed to escaped from these criminals who even tried to kill and now currently taking refuge at New Zouvang P.O. & P.S. Churachandpur District, Manipur.

I am filing this report lately since I have been at different places for safety. Now, since I am able to settle myself at the above mentioned address, I am in a position to file a report today. Hence, prayed that my report be accepted.

In the given circumstances, I humbly pray you to kindly register a **ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of the land. And, for which act of kindness, I shall always remain thankful to you and obliged.
