Subject :- Report on Looting of house, household items/assets and Documents and discrimination of
Schedule Tribe.

Sir,

With reference to the above cited subject I have the honour to report to you as follows :

1. That, I **Zamkhogin** aged about 52 years H/o **Dimneikim** Belonging to the Zou Tribe / Community, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that, I am a Resident of **Thangmeiban Hijam Dewan Leikai Imphal-West Dist., PO/PS., City Police station**
2. That, due to the ethnic violence in the state, at about **5 am** on the **4th May 2023**, a huge mob shouted slogans and attack the Kuki-Zo community in and around the Imphal valley. So, in order to save our lives, I and my family had to run for our lives and took shelter at the nearby CRPF Camp, leaving behind our Rented house at the above mentioned address owned by Smt. Chanbi along with all our Household items and Documents. And in the process they have looted my house including all our household items and documents.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be **Rs. 11,95,800 /- (Rupees Eleven Lakhs Ninety Five Thousand And Eight Hundred) only**
4. Fortunately, we managed to escaped from the criminals, and now currently taking refuge at **Zoumunnuam village Churachandpur .**
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at the above mentioned address. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR , investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.


