

Subject – Report on crimes of vandalism, looting, criminal intimidation, unlawful displacement and discrimination of Scheduled Tribes.

Dear Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a wife of @ T. Pausuanmuan bearing Army No. 4386316-L, 8<sup>th</sup> Assam Regiment and we are a Scheduled Tribe belonging to the Zou Tribe, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, due to the prevailing ethnic crisis in and around Imphal, we left our rented house owned by @ Keisam Mannauba located at Thangmeiband, Hijam Dewan Leikai, P.O.- Imphal & P.S.- City Police and District- Imphal West-795004 on the 4<sup>th</sup> of May, 2023 at around 5.15 AM, took refuge at Central Reserve Police Force (CRPF) Camp near DC Office. Therefore, it came to our knowledge that our deserted resident was looted and vandalized by a group of Meitei/Meitei miscreants suspected to be members of Arambai Tenggol and Meitei Leepun on the 18<sup>th</sup> of August, 2023 at around 11:00 AM.

The criminals broke open the door, destroyed and looted every valuable property from the said resident worth about Rs.6,39,700/- (Rupees Six Lakhs Thirty-Nine Thousand Seven Hundred) only.

That, it may be reported here that the miscreants were shouting slogans like- "KANGLEIPAK YAPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities.

That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and I humbly pray you to kindly register a **ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged. Thus, I am filing the report lately today.
