



Subject: - Report.

Sir,

I have the honour to state that today i.e. 15/11/2023 at about 05:00 pm, a Mobile Vehicle Check Post (MVCP) was conducted by a combine team of CDO-IW led by Inspector P. Achouba Meetei, OC-CDO-IW and myself, personnel of Chingmeirong OP, a column of 4 AR and personnel of E-Coy 216 Bn. CRPF under the command of Shri Md. Riyajuddin, MPS, Dy.SP.(Ops)IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW, in front of LMS Law College, Chingmeirong in the presence of the Executive Magistrate namely Shri. R.K. Debakar, SDC-HQ, Imphal East. During checking the combine team stopped one Mahindra THAR, black in colour without registration number plate having Engine No. TZPZA61691 and Chassis No. MA1UJ2TZ2P2A12097 for verification.

The occupant of the vehicle identified himself as Mutum Rajesh Singh (25 yrs) S/o. M. Shyam Singh of Lilong Chajing Mamang Leikai, Langthabal Kunja, Imphal West A/P Kiyamgei Shantipur, Imphal East. On search of the above vehicle the following articles were recovered :-

1. 1 (one) .32 Pistol marked with "MADE IN ITALY" with 5 (five) rounds in a magazine
2. 1 (one) wallet containing, one Aadhaar Card, RC Card of the said vehicle and Rs. 370/- (Rupees three hundred seventy only)
3. 1 (one) BP vest cover
4. 1 (one) BP Helmet
5. 1 (one) magazine pouch and
6. 1 (one) Xiaomi 11 Lite NE mobile phone along with one JIO SIM card bearing number 89918650400110529593 (Ph. No. 7005045325 as disclosed by him)

Hence, he was arrested for possessing illegal arm and ammunitions and other incriminating items, at the spot at 07:40 pm and the above recovered items along with the Mahindra THAR, black in colour without registration number, were seized at 07:55 pm from his possession by observing formalities and handed over to you for taking further necessary legal action.
