



Subject: FIR for recovery with weapons and two persons.

Sir,

It is to inform you that one platoon of C/27 Bn CRPF was deployed at Village Kaprang under Churachandpur Police Station, Manipur to prevent further looting/ damaged to abandoned houses, shops and properties for 24x7 hours. The same platoon perform searching duty for the looted weapons from Police Station at Kaprang Village and during searching duty at around 1155 hrs two motor vehicle coming from Churachandpur towards Bishnupur and one Yamaha R-15 has dashed against the other Scooty on back side just behind 15 metres from the searching party. On that accident 02 man fall down on the spot and got injured and our searching personnel immediately help the persons. During helping of the person one among them was behaving strangely and in a suspicious manner. Suspecting something one of the constable of our searching party No. 065074906 CT/GD Md Ashraf searched the suspicious person and found one 9mm browning pistol loaded with rounds and an extra loaded magazine from the person highly suspected to be the arms and ammunitions looted/stolen away from the Arm Kote of District Police. On questioning he identified himself as Pao Raju Kipgen (28) s/o Satkhohao Kipgen of Tuiphai Village, Tamenglong District A/P: Kipgen Veng, Churachandpur. The 9mm ammunitions were counted and found to 16 live ammunitions.

Pao Raju Kipgen (28) s/o Satkhohao Kipgen of Tuiphai Village, Tamenglong District A/P: Kipgen Veng, Churachandpur alongwith his accomplice and the recovered arms and ammunitions are handed over to you for taking further necessary legal action.
