Sir,

I have the honour to report that on 14/10/2023 at about 5.30 pm the following persons namely 1) Chesam Ziaur Rahaman(40) S/o Md Khoimu Haji, 2) Chesam Liyakat (27) S/o Md Khoimu Haji, 3) Chesam Boy (25) S/o Md Khoimu Haji, 4) Mrs Khatam (60) W/o Md Khoimu Haji, 5) Chesam Faruque (30) S/o Islauddin, 6) Chesam Khoimu Haji(70) F/o Chesam Ziaur Rahaman, all of Irong Chesaba Mayai Leikai along with their associates numbering about 15/20 persons forcibly entered at my house and assaulted me, my son namely Chesam Shakil Hassan @ Bony aged about 18 yrs and my daughter namely Sahin Mumtaj aged about 14 yrs by holding deadly weapons. Moreover, they also destroyed my house. As a result of which, self, my son and daughter received bodily injuries on our persons and evacuated to hospital for medical treatment.

It is, therefore, requested kindly to take necessary legal action as per law against them at the earliest.
