


The properties that were burn down and looted are as follows:

- ii. Cash – Rs 3,50,000/- approx.
- iii. Household items – Rs 3,00,000/- approx.
- iv. Jewelry items- Rs 90,000/- approx
- v. Utensil Items – Rs 70,000/- Approx
- vi. Furniture items- Rs 1,00,000/- approx.
- vii. Gas cylinder 4- Rs 15,000/- approx
- viii. Electronic items – Rs 50,000 approx
- ix. Cloths items – Rs 30,000 approx
- x. Pets items- Rs 10,000/- approx.
- xi. One Jupiter (two wheeler)- Rs 50,000/- Approx
