


Sir,

I have the honour to report that, I am born and brought up at Khuga Tampak, Zo-veng, CC-Pur, Manipur and living with my family of 8 members. I am a businessman by profession. On 04/05/2023 at around 10:00 am, my three stories RCC house located at Khuga Tampak, Zo-veng, CC-Pur, was set on fire by some Kuki tribes rioters by holding gun, sword, stick etc. as well as attacked to our life. The ground floor of my house is divided into two parts and one is used as grocery shop and another is used as garments shop. Before burning down, they have looted/stolen 6 Nos. of cooking gas cylinder, some Gold ornament worth Rs. 5 lakhs and around Rs. 10,00,000/- in cash and many more from my house. The approximate value of the grocery items is Rs. 5,00,000/- and garments items is Rs. 10,00,000/- and all are turned into ashes. Beside this, my two tailoring shop and one garment show room name as Modern Tailoring located at Hiangtam-lamka Tipaimukh road, CC-Pur were also broken down and looted/stolen by them. The approximate value of the looted items is around Rs. 1 (one) crore excluding the value of shops. Their illegal act lead many properties turned into ashes and disturbing peace and tranquilities to the general public worstly.

It is therefore requested you to kindly take up necessary action against those Kuki tribes rioters for their illegal and merciless acts as per law.
