

Today i.e. 28/10/2023 at: 8.10 pm received a reliable information that on the same day at about 8.00 pm one Maruti Car 800 bearing registration number not known plying from Sekmai jin side towards Wangoi side along Mayai Lambi Road knocked down two male pedestrians who were walking along Mayai Lambi road near Sofia Car Wash, Mayang Imphal Konchak Mayai Leikai due to rash or negligent driving on the part of the unknown driver of the Maruti car 800. As a result of which the two male pedestrians received serious injuries on their persons and evacuated to Hospital for medical treatment.
