Sir,

I have the honour to report that, I am living at Bijang Khunou Meetei Leikai, Churachandpur with my family of 3 members since 2002. I am a businessman by profession. On 03/05/2023 at around 07:30 pm, some Kuki tribes rioters by holding gun, sword, stick etc. stormed at our house cum grocery shop located at Bijang Family Land, Churachandpur along the road side of main road. Then, they broke down the main door of my house and Shutter of the grocery shop and looted/stolen most of the house hold items like bed box, two double beds, two single beds, two iron godrej, one gas box, one dressing table, one fridge, one washing machine, one micro oven, two gas stock, five nos. of cooking gas cylinder, two television, one computer sets, one invertor battery, one generator, some Gold ornament worth Rs. 5,50,000/-(five lakhs fifty thousands) and around Rs. 1,30,000/- (one lakh thirty thousands) in cash and many more from my house and grocery shop. Further, they set on fire the remaining items of my house and shop including valuable documents like land patta, certificate and others at the main road. The approximate value of the lost house hold items is Rs. 30, 00,000/- (thirty lakhs). Their illegal act lead many properties turned into ashes and disturbing peace and tranquilities to the general public worstly.

It is therefore requested you to kindly take up necessary action against those Kuki tribes rioters for their illegal and brutal acts as per law.
