After the said unfortunate incident/mob violent, my family are felling our village and my family is taking shelter at a relief camp (Ideal Girls' Collage) situated at Akampat, Imphal East District, Manipur.

It is, therefore, prayed that the respected Sir may kindly initiate and take necessary legal action(s) against the accused persons and the persons involved in the said inhuman acts and heinous crime committed by the accused person and persons involved as per law of the land as early as possible.
