

Today i.e. 06/11/2023 at 9:50 pm received a reliable information that on the same day at about 9:45 pm some unknown armed miscreants who came by riding an Alto Car silky silver in colour bearing registration number not known along Mayai Lambi Road from Sekmaiin side towards Imphal side opened fire towards the residential house of Hon'ble MLA, Mayang Imphal AC namely Shri Kongkham Robindro Singh S/o K. Manglem Singh of Mayang Imphal Thana Awang Leikai creating panic to the family members of Hon'ble MLA as well as to the nearby localities. Thereafter, the unknown armed miscreants left the place immediately by driving the vehicle Alto Car towards Imphal side. As a result of the incident some portion of the fencing gate and residential house wall of Hon'ble MLA got slightly damaged.

So, a Suo-Motto case under FIR No. 123(11)2023 MIPS, U/S 506/427 IPC & 25(1-C) A. Act has been registered for investigation.
